# Terms and Conditions

1. The card is the property of the Bank and must be returned within 7 days of receipt of notice for termination of membership or withdrawal of privileges of the card for any reason whatsoever or on the expiry of the card.
2. The Card is not transferable under any circumstances and can be used only by the cardholder.
3. The Bank reserves the right to seize/cancel the card issued, if found at any date, the information submitted by such cardholder is false or the card has been misused.
4. The Bank reserves the right to terminate membership, withdraw the privileges attached to the card or not renew the expired card at any time and to call upon the cardholder to surrender the card with or without assigning any reasons whatsoever.
5. Use of the card after notice of withdrawal or termination of the membership is fraudulent and may be subject to legal action by the Bank in accordance with the prevailing law.
6. Security of the card and the PIN issued to the cardholder are entirely at the cardholder's risk and responsibility. The cardholder undertakes full responsibility for all transactions made by the use of the card whether or not made with his/her knowledge or authority.
7. The cardholder agrees to inform the Bank in writing regarding lost/stolen, damage of card and disclosure of PIN. The cardholder will be held liable for all the transactions received prior to this notification.
8. The Bank shall not be responsible in any way for non-availability of ATM services or POS terminals at Merchant outlets for any reason whatsoever arising as a result of malfunctioning of the Card or ATM or POS, insufficiency of funds in such machines, mechanical or power supply failure or otherwise.
9. The Bank reserves the right to call for the additional deposit, if the card by any means cross the amount greater than the amount deposited.
10. The cardholder undertakes to indemnify the Bank and to keep the Bank indemnified against all losses, damages, cost or expenses incurred and sustained by the Bank arising out of cardholder's failure to observe any of the terms and conditions mentioned herein.
11. As per Nepal Rastra Bank's regulation, cardholder has to submit documents to the bank for transaction at any given time, as and when required by the bank.
12. The Bank reserves the right to amend these terms and conditions at any time with or without prior notice to the cardholder and such amended terms and conditions shall be binding on the cardholder.
13. It shall be sole responsibility of the Cardholder to reconcile the transactions of the UPI Prepaid card statement. Any dispute on the Card transaction should be lodge to Card Center within 15 days of transactions date to avoid rejection due to delay in lodging the claim with UPI.
14. In case of any dispute/charge back, prevailing rules and regulation of UnionPay International, Himalayan Bank and Nepal Rastra Bank shall prevail.
15. The Cardholder shall not use the Card for any act prohibited by UnionPay International, Nepal Rastra Bank or any other applicable law of the country. The Cardholder shall be bound by all the prevailing rules of UnionPay International, Himalayan Bank Ltd., Nepal Rastra Bank and Government of Nepal and in the event of failure to so abide, the Cardholder shall bear any resulting damage, penalties and/or action as a consequence thereof.
16. Billing will be done as per UnionPay International and Himalayan Bank's rules & regulations.
17. It shall be the responsibility of cardholder to retain use transactions slip for future reference.
