TERMS AND CONDITIONS STATED HEREUNDER RELATE TO THE USAGE OF THE HIMALAYAN BANK AMERICAN EXPRESS® GOLD CREDIT CARD BY THE CARD HOLDER

- 1. The Card is a property of the Bank at all times.
- 2. The Card and PIN issued to the Cardholder is non transferable and is entirely at the risk and responsibility of Cardholder. The Cardholder shall not disclose the PIN or permit possession of the Card to any other person. Cardholder(s) will be fully responsible for all the transaction carried out through the card.
- 3. It shall be the Bank's prerogative to accept or reject any card application and it shall not be mandatory to the Bank to disclose the reason whatsoever.
- 4. Supplementary Card shall be processed on request and authorization of the Primary Cardholder. It shall be the responsibility of Primary Cardholder to honor all charges/claims incurred through the Supplementary Card(s). The membership of the Supplementary Card Member(s) shall be subject to continuation of Primary Card Membership.
- 5. Any sales slip signed by the Cardholder shall be the conclusive proof of the charges recorded therein as incurred by the Cardholder himself and will be charged by the Bank to the Cardholder.
