The security deposit shall not earn any interest. The photocopy of the deposit slip should be included or submitted along with bid document in the sealed envelope.
4. The bidder must mention the specifics of the vehicle they want to purchase in their bid application. For each vehicle, bidders are required to deposit separate security deposit amounts.
5. The security deposit of the successful bidders shall be retained, and security deposit of unsuccessful bidders shall be refunded within 45 days from the date of last submission deadline.
6. The successful bidder has to pay the full amount within seven days from the date of bid opened, if not the bid securities will be forfeited, and the vehicles will be sold to next high bidder who has submitted the highest offer for the respective Vehicle.
7. On acceptance of offer, the delivery of the vehicles will be given to the offeror only after Cash /Banker's Cheque deposited by the offeror for the full payment is realized.
8. The ownership transfer has to be done by the successful bidder himself at his own cost. Himalayan Bank Limited shall issue only an ownership transfer letter to Yatayat Office.
9. The BANK shall pay road tax for the current fiscal year only.
